

ISSF Annual Conservation Measures & Commitments Compliance Report

June 2015

Overview

The following report details the progress being made by ISSF participating companies in achieving full compliance with all ISSF Conservation Measures and Commitments in force as of 31 December 2014.

Per the ISSF Strategic Plan:

- ISSF tracks adherence by ISSF participating companies with all in force ISSF conservation measures and commitments
- · ISSF will publicly report on ISSF participating company compliance on at least an annual basis
- · Verification of ISSF participating company compliance will be conducted by external, non-ISSF resources
- Where less than full compliance is achieved, mitigation measures will be required within a specific timeframe, after which those demonstrating major non-conformance will be referred to an ISSF compliance committee

Audit Process

In 2014, ISSF further strengthened its independent auditing and reporting process. ISSF engaged MRAG Americas to review and improve ISSF's audit process, as well as to conduct an audit of the performance of the participating companies against the conservation measures and commitments in-force in 2014.

As a result, for 2014 ISSF is delivering an additional level of clarity to provide interested stakeholders with greater definition and explanation of conformance by individual measure. Categories of conformance now include:

Conformance	Company can provide evidence of full compliance
Minor Non-Conformance	Company does not fully comply with a particular conservation measure or commitment, but this does not compromise the integrity of ISSF initiatives
	Example: Participating Company CEO Certificate of Compliance includes some, but not all, required elements
Major Non-Conformance	Company does not comply with a particular conservation measure or commitment and this compromises the integrity of ISSF initiatives
	Example: Participating Company does not submit CEO Certificate of Compliance.

The results included in this report are the product of MRAG's independent, third party audit of information provided directly to the auditor by ISSF participating companies or obtained from other sources such as RFMO reports or the PVR, as detailed in the established <u>Audit Protocol</u>.

Tracking Continuous Improvement

This report details the level of compliance with each conservation measure or commitment and aggregates compliance by company. Individual companies are not identified in this report; an individual company may choose to share its specific results directly with a stakeholder upon request.

This report will be updated periodically throughout the year to reflect any improvements in compliance by ISSF participating companies with conservation measures and commitments in force as of 31 December 2014. Any conservation measures in-force beginning in 2015 will not be reported until ISSF's 2015 annual report, published in 2016.


MRAG's audit showed that on eighteen of the conservation measures at least two companies had minor nonconformances. These minor non-conformances generally involved instances in which participating companies provided documentation showing some, but not full, compliance with a conservation measure, which in MRAG's view did not compromise the integrity of ISSF initiatives.

MRAG's audit also showed that major non-conformance occurred on five of the 21 audited conservation measures and commitments. These major non-conformances involved instances where a participating company could not demonstrate any compliance with a particular conservation measure.

CONSERVATION MEASURES AND COMMITMENTS WHERE MAJOR NON-CONFORMANCE OCCURRED:

No transactions in tuna caught by vessels not on the authorized vessel record of the RFMO	One company purchased from more than one vessel tha was not listed on the relevant RFMO record

The certification provides a participating company's assessment of its compliance; however, the audit process may identify areas of non-conformance that may or may not have been discovered by the company.

¹The Compliance Policy requires each ISSF Participating Company to submit an Annual Compliance Certification, signed by the CEO or other high-level person, covering the prior calendar year certifying that they completed an internal review of procedures to confirm that the member maintained adequate records of compliance, adequately trained staff responsible for compliance and either complied with all in-force ISSF conservation measures or disclosed any found instances of non-compliance. If such a review reveals non-compliance, the member must describe the non-compliance as well as outline the steps the member will take to come into compliance along with a timetable for doing so.
